Assembly Status Report

03/15/24 03/15/24	Matt18.org website originated Notice of Inaugural Assembly Meeting on Matt18.org website
03/15/24 04/09/24 04/10/24	and sent by email. FOHC Elder Board sent out churchwide email response to Assembly Meeting. Second Posting of Assembly Meeting on Matt18.org website and sent by email. Elders Craig Clark and David Berry visited Richard Ohendalski at his office To inform him that the FOHC Elder Board had revoked his church membership. Richard asked for that decision in writing, Craig Clark denied this request. Clark said membership was revoked because "his actions were an attack on Church leadership." Richard was told not to come on FOHC grounds with threat of criminal trespass proceedings.
04/13/24	FOHC Elder Board sent out a church wide email to clarify the church Position in response to the Matt18.org call for an Assembly Meeting.
04/19/24	Elders informed Eric McIntush by email that his FOHC membership had been revoked. Stated reason was, "due to your recent actions that have been intended to divide, disrupt and confuse those who attended FOHC." Elders informed him not to come on FOHC property or criminal trespassing charges would be filed.
04/27/24	Assembly meeting report for 04/21/24 Assembly meeting
04/28/24	FOHC Elders removed Gene Browning from his position as a FOHC Deacon. Gene had served for over 17 years as a Deacon. No reason was Given for his removal. Gene Browning sent a request to the FOHC Elder Board on 05/01/24 for a meeting to discuss why he was removed. Elder Board made no attempt to contact Gene by phone, letter, email or in personal contact.
05/15/24	Posting of Assembly meeting on Matt18.org and by email for 5/19/24 meeting.
06/04/24	FOHC Elder Board retained Stalcup Law Firm of Dallas, TX to file a legal "Notice to Cease and Desist" notification by both email and 1st Class Mail. Notice was sent to at least 20 members of the Assembly Meeting threatening a Lawsuit.
06/06/24	May 19 th Assembly – Report of Assembly Activity & Resolutions. Complete copy of this Report was sent to each member of the FOHC Elder Board.
06/10/24	FOHC Elder Greg McKeever contacted the Assembly Liaisons to request a meeting to discuss the Assembly Report. Meeting schedule: 06/12/24 6:30 pm at FOHC.
06/10/24	Theresa Hess church membership was revoked.
06/12/24	Assembly Liaisons: Craig Favorat and Gene Browning met with 3 of the 7 FOHC Elders: Greg McKeever, David Jones & Monty Pendley. Subject of discussion was both FOHC concerns and the Assembly concerns. This meeting lasted approximately 3 hours.

06/12/24 The 3 Elder Board members stated that 4 major items had to be addressed by the Assembly prior to any options for further discussions.

The 4 items were:

#1: Matt18.org website must be removed from the internet

#2 All mass emails from the Assembly must stop

#3 Stop any and all recruiting inside the church for the Assembly

#4A The Assembly must accept that FOHC will remain an Elder Ruled organization.

#4B The FOHC Statement of Faith will remain in tact and will not be suspended.

The Liaisons agreed to take that information back and inform the Assembly of the Elder Board decisions.

- O6/15/24 Assembly Meeting was held to discuss the Liaison/Elder meeting of 06/12/24. Assembly agreed to discuss the 4 Elder requirements as long as the Assembly could obtain and read the FOHC By-laws.
- 06/19/24 Liaisons sent a request for another Liaison/Elder meeting to discuss the 06/15/25 meeting. The letter requested a copy of the FOHC By-Laws for review by the Assembly.
- FOHC Elder David Jones called both Liaisons to notify the Assembly that the FOHC By-Laws request was categorically denied. He informed the Liaisons that no further meetings with Elders would take place unless the 4 items outlined by the Elders were agreed with.

Liaisons told Elder Jones that information would be taken back to the Assembly to discuss during the 06/30/24 Assembly Meeting.

O6/30/24 Assembly met and discussed the decision of the Elder Board to deny access to the FOHC By-Laws and review and discuss available options. The Assembly agreed to generate an Assembly Status Report.

The Assembly adjourned without designating a future meeting date.
